Initially, the company was known as Cadbury-Schweppes Public Limited Company before the separation of its US beverage unit which is currently known as Dr Pepper Snapple Group (Cadbury PLC, 2010, p. 5). This process was undertaken through a demerger that took place between the two firms.

Schweppes merged with the Cadbury Group, a well-known confectionery company, to form Cadbury Schweppes plc in 1969. In 1969, the Schweppes Company merged with Cadbury to become Cadbury Schweppes.
